In accordance to the provisions under section-16 and No.DSE/Samagra/PwD/18-46/2019: Section-31 of the Rights of the Person with Disabilities Act, 2016(RPwD Act) dated 27th December 2016, the Governor of Nagaland is pleased to notify:

- 1. The appropriate authorities shall endeavour that all educational institutions funded or recognised by the government to provide inclusive education to the children with disabilities and towards that end shall-
  - Admit them without discrimination and provide education and opportunities for sports ŧ. and recreation activities equally with others;
  - Make buildings, campus and various facilities accessible; ii.
  - Provide reasonable accommodation according to the individual's requirements;
  - Provide necessary support individualised or otherwise in environments that maximise iii. academic and social development consistent with the goal of full inclusion;
  - Ensure that the education to persons who are blind or deaf or both is imparted in the most appropriate languages and modes and means of communication;
  - Detect specific learning disabilities in children at the earliest and take suitable vi. pedagogical and other resources to overcome them;
  - Monitor participation, progress in terms of attainment levels and completion of vii. education in respect of every student with disability;
  - Provide transportation facilities having high support needs. viii.
- Notwithstanding anything contained in the Rights of Children to Free and Compulsory Education Act, 2009,
  - every child with benchmark disability between the age of six and eighteen years shall have the right to free education in a neighbourhood school, or in a specific school, of i.
  - Appropriate authorities shall ensure that every child with benchmark disability has access to free education in an appropriate environment till he/she attains the age of ii. eighteen years.
