ORDER

WHEREAS, by Advertisement bearing No. DTA/ESTT-119/19 dated 14.10.19, published in the local Daily, the Office of the Directorate of Treasuries & Accounts, Nagaland, Kohima, had invited Naga Local Inhabitants to fill up 5 (five) posts of LDA-cum-Computer Assistant, 4 (four) posts of Accounts Assistant and 35 (thirty-five) posts of Junior Accounts Assistant under the establishment of the Directorate of Treasuries & Accounts, Nagaland. It was observed that though reservation of seats for Backward Tribe was mentioned, no mention was made as to the reservation for Persons with Benchmark Disabilities as per the existing Policy of the State Government.

This Court issued a Notice dated 25-09-2020 for compliance within 3 months' time to make a course correction and to rectify the blatant disregard of the Government Notification for 4% reservation for Persons with Benchmark Disabilities by publishing a Corrigendum whereby, the Advertisement bearing NO.DTA/ESTT-119/19 dated 14.10.19, must include reservation for Persons with Benchmark Disabilities along with the number of posts reserved in each group of posts. Further, to reschedule the Written Examination for only those candidates with benchmark disabilities so that it is not contrary to the Notification bearing NO.DTA/CON-119/2019-20 dated 8.05.2020, declaring the list of candidates selected in the Written Examination held on 14.12.19.

On 19-02-2021, a copy of the Advertisement bearing No. DTA/ESTT-119/19/01 dated 4.01.2021, was submitted to the Court and as per Notice dated 25-09-2020, whereby, necessary rectification and modification has been made in continuation to the previously published Advertisement bearing No. DTA/ESTT-119/19 dated 14.10.19.

Hence, with the above rectified Advertisement dated 4.01.2021, which is placed on record, the matter has been complied with and stands disposed off with a direction that in future course of action, the rights and privileges of persons with disabilities guaranteed under the Constitution of India and more particularly under the Rights of Persons with Disabilities Act, 2016, should not in any way be overlooked or denied.
